Rules & How to Enter:

1. Print off application form, complete, place in envelope and include entry fee payment of \$25.00. Mail should be postmarked by August 1st. Mail to:

2. Entry forms are available at www.heartoftheozarks.weebly.com or www.bentoncountyfairar.org
3. First in with paperwork will be last out in line up. If a group meets capacity, we will close that age group. Get your entry fees in early to ensure your spot in lineup.
4. Mandatory rehearsal for parent or guardian of the contestant on **Saturday, August 13th @ 3:00** at the Fairgrounds Auditorium. This rehearsal will confirm your Child's entry and you will get your lineup number. In addition, instructions for stage modeling, line-up and pageant details will be covered. It is not necessary or recommended for the contestant to attend.
5. The pageant will be held, **Saturday afternoon of the Fair, August 20th, at 1:00 pm for 0-3 yrs and 3:00 for 4-9 yrs**. Contestants will need to sign in at the registration table 20 minutes prior to their division time. (Registration Table located at entrance of auditorium.).
6. **Contestants should arrive dressed and ready to proceed to stage**. There will NOT be dressing rooms available. Contestants will only need one outfit for this competition. Play Wear or Casual Dressy. **NO PAGEANT ATTIRE IS ALLOWED**. Points will be deducted if your child wears pageant wear. We will not say anything to you, but the judges will be instructed to deduct points!!!!
7. Winners receive rhinestone crown for girls and a nice Medallion for boys. Runner ups will be announced and an Audience Favorite award will be given to the contestant who receives the most votes in each age group. Votes are \$1.00 each.
8. Each contestant must be a legal resident of Benton County. Previous contestant winners are not eligible to enter again in the same age division. If you won last year and wish to crown then you must sit out competing in this year's pageant.
9. One Parent or guardian of a 0-3yr contestant is asked to help their child line up behind stage and take them on stage during competition. **THERE WILL NOT BE ANY ON STAGE QUESTIONS.**
